Terms and Conditions



These terms and conditions ("Terms") apply to the travel gift card, fees waiver and moving packaging promotion ("Promotion"). By entering the Promotion and/or applying for an occupation right agreement ("ORA") to enter into this Promotion, you are deemed to accept these Terms.

- 1. The Promotion is for:
 - a. a gift card from House of Travel ("Travel Gift Card"). The Gift Card is for \$10,000;
 - b. a furniture moving package valued at up to \$5,000 ("Moving Package"); and
 - c. a waiver of the weekly fees you pay at the Participating Village for 12 months.
- 2. The Promotion is open to new residents applying for an ORA for a selected independent living unit at a Participating Village ("Eligible Unit").
- 3. To qualify:
 - a. you must submit an application between 1 October 2025 and 14 December 2025 (inclusive) for the occupation of an Eligible Unit;
 - b. we must accept the application; and
 - c. you must sign and settle an ORA for the Eligible Unit (including paying the Occupation Licence Payment in full) within four months of the application date.
- 4. As the Promotion requires entry into and settlement of an ORA, our usual resident criteria apply.

Travel Gift Card

- 5. We will give you the Travel Gift Card promptly after the later of the date that you have paid your Occupation Licence Payment in full and the expiry of the 90 day period from the Commencement Date.
- 6. The Travel Gift Card is subject to House of Travel's terms and conditions, including any expiry dates or restrictions on use, which may be viewed

at www.houseoftravel.co.nz/hot-info/house-of-travel-gift-card (see Gift Card Terms & Conditions).

- 7. We accept no responsibility for the booking, use, or redemption of the Travel Gift Card, including travel availability, cancellations, or changes and give no warranty or representation as to the services provided by House of Travel.
- 8. We are not liable for any loss or damage to property or for any injury, illness or death, or for any damages or claims whatsoever arising from your use of the Travel Gift Card.
- 9. Any costs above the value of the Travel Gift Card are the responsibility of the voucher holder.

No Weekly Fees for 12 Months

- 10. Your Weekly Village Fees will be waived for a period of 12 months from the Commencement Date of your ORA.
- 11. The amounts of the Weekly Village Fees are those specified in your application.
- 12. Following the expiry of the 12 Month period you must commence paying your Weekly Village Fees.

Moving Package

- 13. We will pay the cost of furniture moving services from Smart Express or Sort My House, valued at up to \$5,000.00 to assist you with your move into your independent living unit. If either of these providers is not available or not available in your area, instead we will pay \$5,000 to you by an adjustment of the amount you are required to pay us to settle the Occupation Licence Payment in full.
- 14. If you wish to purchase services that cost more than \$5,000 you will be responsible for the cost of them to the extent that they exceed \$5,000. You are directly responsible for the cost of any additional services you choose to purchase.

15. Your use of the services is at your own risk, Oceania is not responsible for any loss or damage caused by the service provider.

Cancellation

- 16. If you cancel your ORA in accordance with clause 15 (Your Cooling Off Right) or clause 19 (Your 90 Day Right Place Guarantee) of your ORA you will be required to reimburse us for the cost of the moving services we paid for and for the Weekly Fees that we waived.
- 17. We will be entitled to deduct money you are liable to pay us under clause 17 from any payment we are due to make to you following cancellation of your ORA.

General

- 18. This offer is not available to existing residents of the Participating Villages.
- 19. We reserve the right to amend these Terms and/ or extend, suspend or terminate the Promotion at any time.
- 20. Unless otherwise stated or agreed by us, the Promotion cannot be used in connection with any other discount, offer or promotion.
- 21. To avoid doubt, the Promotion does not apply to care suites or any care related accommodation.
- 22. The Travel Gift Card and Moving Package are not transferrable and cannot be exchanged for cash.
